- 5. Contractor to replace an **additional 270 SF** more or less, of additional Roof approx. 10 ft below main roof; Plus replace **(2) each additional roof drains**. See Sketch #1 this Addendum for clarification.
- 6. Replace existing domed sky light with NEW Skylight. Modify curb and install a new Velux translucent daylight S-series double pitch skylight with double wall polycarbonate panels and clear anodized aluminum framing. Approximate size is 6ft by 15ft. Contractor must confirm dimensions before

- 8. REMINDER: Contractor's BID FORM shall reflect the additional work of this Addendum in the lump sum price.


